Previous Cut-Back Recommendations of the Secretary-Treasurer:

- Conduct all daily operations in a “maintenance” mode only for all existing programs, infrastructure, services, etc.
- For the General Fund & Drainage, conduct all daily operations in a “cut back” mode since a “maintenance” mode was never followed
- Discontinue the seeking of additional grants (requiring matching funds) until all existing funding can be exhausted
- Discontinue the expansion of parks and recreation due to lack of availability of operational funds
- Place a travel/expenditure freeze for all travel for 2026
- Merge the 911 Admin. Asst. with the Housing Dept. Intake Worker
- Upon a retirement in the Housing Dept, do not fill the position due to the workload not warranting a 3-person office
- Discontinue/reduce the free/reduced costs events held at the Assumption Parish Community Center and Agricultural Complex
- Implement a process for capturing lost revenue for businesses operating without an occupational license and advertising through social media
- Implement a process to enforce building codes/permit violations
- Zero-out cumulative recreation balances carried forward that are not being expended
- Zero-out old drainage projects still on the books that are unable to be completed
- Eliminate Juror lighting that is funded through the General Fund
- Discontinue funding to the Chamber of Commerce for hosting banquets, etc.
- Additional increases in user fees needed more often for the Sewer District and the Solid Waste Fund to avoid the General Fund transfer
- Meet with the 23rd JDC to discuss the budget shortfalls and rising costs of the Criminal Court fund

Add'l item for consideration:

- Consider proposition to re-allocate the current 2 mills dedicated to the Library Fund for Inmate Needs/Expenditures within the General Fund (Est. \$500,000 annually)
- Consider proposition to re-allocate 1/8 of sales tax generated from the 1% Sales Tax Fund for Inmate Needs/Expenditures within the General Fund (Est. \$400,000 annually)

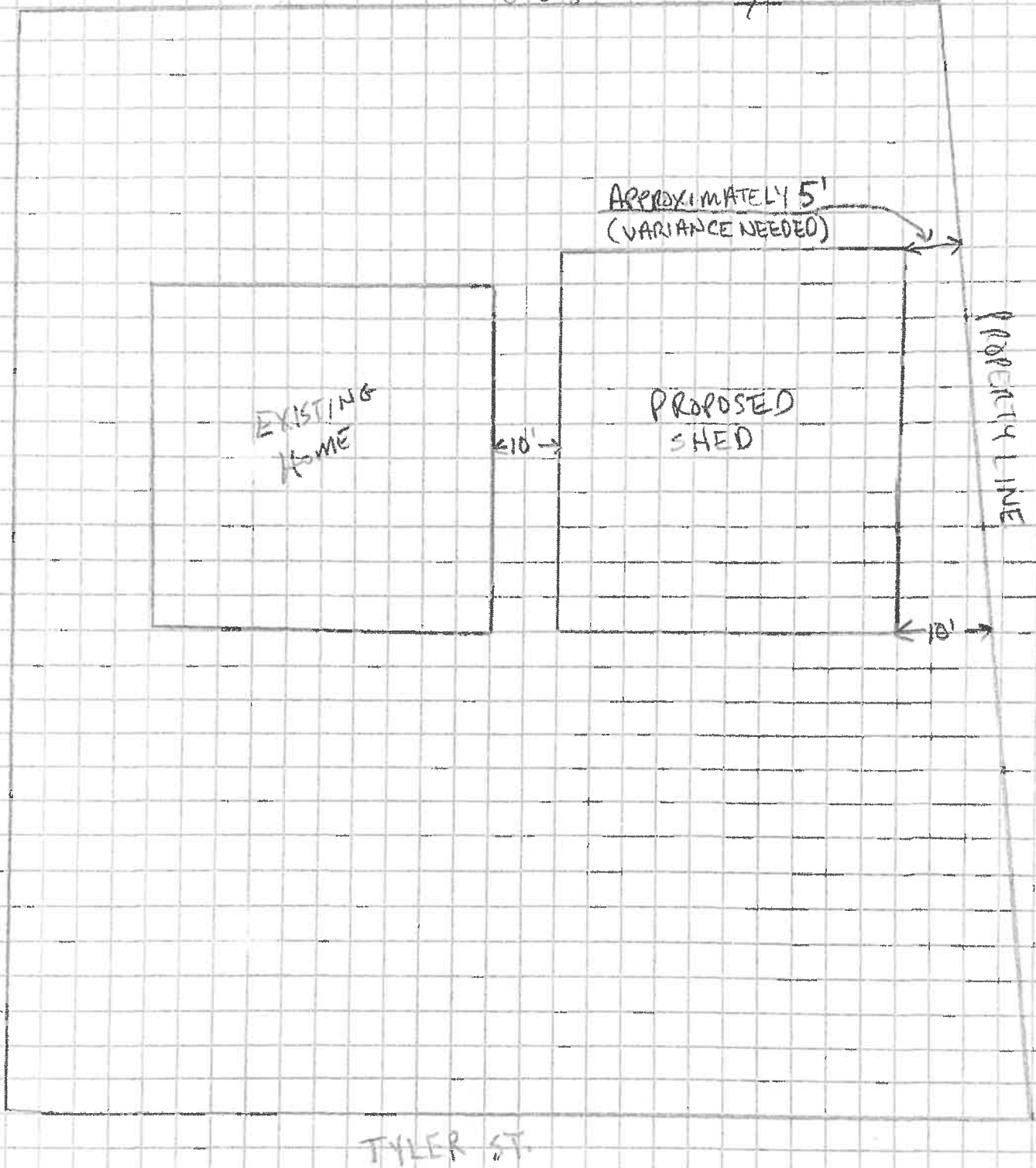
