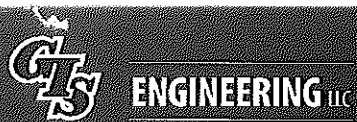

- Congressmen Scalise, Carter, Higgins, and Graves

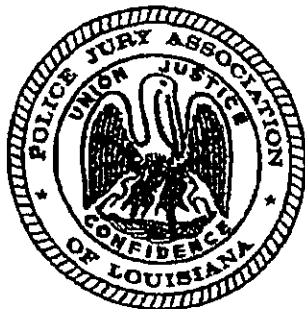
